When LEC became its own 501c3 in 2017, we knew becoming financially independent would be a long process.

Along with an annual subsidy, SSND currently pays:


- Executive Director's Salary and Benefits
- Office Space (in-kind)
- Land for the Community Garden (in-kind)

We are grateful for the continued support of SSND. In fact we could not operate without it. To that end, we are working towards our future financial sustainability. Any additional income surplus has been invested in a "nest egg" of sorts towards our goal of future financial independence.

Other notes of importance:

- Portions of the grants that we recieved carry over into the next fiscal year
- Covid-19 has continued to effect our Programming Income

### **COMMUNITY FARM**

In March of 2021, LEC took over management of the Blue Earth County Farm. While the Farm has been in operation for over a decade, this year it was moved to a new location and so we were starting from scratch with an empty field. With the support of Blue Earth County we hired a Farm Manager, and with her work, along with the work of many community volunteers (individuals, companies, church groups, and more) we turned that empty plot of land into a thriving growing space.

Food harvested from the Farm was donated to our Community Partners, ECHO Food Shelf, FOCP Backpack Food Program, CADA House, SW MN Food Recovery Program, and Partners for Affordable Housing.

#### COMMUNITY CONNECTIONS

Creating Connections in our community is at the heart of LEC's mission. We are proud to continue our joint venture with MNSU's School of Allied Heath and Nursing cultivating the Eng-AGE-ment Garden, a dementiafriendly garden for residents of Pillars Senior Living Community.

We also began a new partnership this spring with MAC-V, providing a gardening and gathering space for veterans in the Mankato area. They came weekly up to the Gardens, for coffee, conversation, and to tend their garden plot.





## GROWING THROUGH GARDENING

While we have been offering kids' gardening classes for over 15 years, we have had a special partnership with Mankato MYPlace (formerly Boys and Girls Club of Mankato) for the past 4 years.

The MY Place garden plot in our Community Garden provides access to the magic of gardening for children who may not have had previous garden experiences. The group visits their plot weekly throughout the summer and works with our staff growing organic vegetables (tomatoes and cucumbers are among the most popular) that they get to eat and take home to share with their families.

## CONTINUED FARM GROWTH

We have big plans for the Community Farm space - cultivating a free food forest, growing native pollinator plants, partnering with immigrant and refugee communities, and expansion of our soil, garden, and farm training programs.

For the 2022 growing season we will be focusing on implementing sustainable soil management techniques including rotational cover crops, carbon building mulch, and possible small livestock addition.

## USDA GRANT WITH REGION 9

As we work towards the above goals of partnering with immigrant and refugee communities and expanding training programs, we have partnered with Region 9 to apply for a USDA Grant.

This grant will allow us to work with area immigrant/refugee communities, giving them space to grow traditional foods that they can then sell at the Farmer's Market and/or donate to local food shelf/community organizations.

## INVESTING FOR THE FUTURE

As we work towards our future financial independence from the School Sisters of Notre Dame, we have taken steps to invest our "nest egg" with the Mankato Area Foundation's Agency Funds.

Through this partnership, MAF pools and invests LEC's assets with those of the Foundation, thereby providing responsible and professional management on our behalf. This step gives us confidence and professional backing as we move forward towards our future fundraising goals, as well as making it possible for us to now manage legacy and larger donations.
